#### **OVERVIEW**

The Inland Valley Development Agency (IVDA) has facilitated the coordination of a number of infrastructure improvements within the Inland Valley Infrastructure Corridor (IVIC), which is adjacent to the 3rd and 6th Street corridors in the cities of Highland and San Bernardino. Infrastructure improvements provide solutions to current thoroughfare issues in the area that are experienced by local residents and businesses. It creates conditions to efficiently connect future and existing development to roadways while providing safe spaces for pedestrians, cyclists, transit and motor vehicles. IVIC is a result of years of input and effort by IVDA and many regional partners. IVIC does not propose land use or zone changes as part of the projects.

#### **IVIC IMPROVEMENTS**

IVIC improvements are envisioned to be developed over a period of about 20 years in an incremental manner.

**Water** - enhancements to potable water distribution system, use of recycled water, including 3.5 million gallon storage reservoir and new water well

**Sewer** - improves capacity and upgrades system, including 5,000 feet of sewer lines

**Roadways** - improves traffic circulation, safety, mobility, and roadway conditions, including up to 20 miles of roadway

**Stormwater drainage** - addresses longstanding flooding issues by improving drainage systems, including City Creek Bypass Channel improvements

**Utility integration** - efforts to include other utilities/emerging technology that can be integrated concurrently with above infrastructure improvements

## **ENVIRONMENTAL DOCUMENT SCHEDULE**

A Draft Environmental Impact Report (Draft EIR) has been prepared for IVIC. It adheres to California Environmental Quality Act (CEQA) requirements and provides the public and decision-makers detailed information about the project's potential environmental effects while identifying ways to minimize those impacts.
